INVITATION TO PRE-QUALIFY: STREET LIGHTING LIGHT EMITTING DIODE (LED) LUMINAIRES in the STATE of QATAR

The State of Qatar has experienced rapid economic growth over the last several years. This economic growth has resulted in increased demand for the state to construct and provide world class infrastructure. The Public Works Authority (PWA) strives to develop the state's infrastructure and public utilities to the best international standard levels. The highway infrastructure is being developed taking into consideration sustainable development model. Energy efficient products and world leading technologies are utilized to achieve the goal. The PWA has identified that correctly deployed LED technology across the State of Qatar will assist in the reduction of carbon emissions, improve energy efficiency and reduce associated Roads maintenance. PWA wishes to select a short list of competent manufacturers (the "Pre-Qualified Applicants") and associated LED luminaires for inclusion within the approved list of materials for street lighting works. The PWA is seeking proposals from Applicants (where Applicants shall be world leading, industry established Street Lighting LED Luminaire Manufacturers) to demonstrate their experience, commitment and products compliance with the "Street Lighting Luminaire Specification - LED" applicable across the State of Qatar.

CONTRACT SCOPE OF WORKS: I I

The Public Works Authority is seeking, where identified as best value, to make LED the preferred light source on all street lighting infrastructure projects. The PW A seeks to compile an Approved list of Materials (LED luminaires) for Street Lighting works for use in the State of Qatar by appointed contractors. The approved list of materials will be managed by the PWA and could be used by other industries and bodies in the State of Qatar.

THE TECHNOLOGY LOT IS AS FOLLOWS WITH EXAMPLE OF REQUIREMENTS:

Street Lighting Light Emitting Diode (LED) Luminaires - for the illumination of Roads infrastructure such as Secondary and Tertiary roads, including such area footpaths, cycle paths and landscape/ recreational areas.
